The price of the courses includes:

- **The flying equipment** for the courses cycle 1 & 2 (recent glider, harness with back protection, radio, helmet, rescue parachute). You are responsible for your equipment during your course. If you damage or lose it, you will have to replace it or pay for it. You will have good quality equipment, we please ask that you take care of it.
- **The presence and instruction of one or two instructors** (professional state diploma BEES 1st degree & BPJEPS or DEJEPS or student instructor BPJEPS).
- **The minibus** (9 seats) to drive to the different flying sites in the valley.
- **Different documentation** (FFVL's passport, theory leaflet)

The price of the courses does not include:

- **The lift tickets** to get to the take offs (prices and information at www.compagniedumontblanc.fr).
- **The flying equipment** for the "à la carte" courses like trips, high mountain flights and private courses.
- **Third party liability Insurance (Air Sports)** which is a legal requirement. You must provide [a medical certificate](#) for its delivery. Further options are available such as personal accident coverage and repatriation insurance.
- **Personal equipment:** warm clothes, good hiking shoes, sunglasses, light gloves, ...

Payment: by cash, or [on-line by bank card](#) or by [bank transfer](#). You can also pay by cheque payable to "Les Ailes du Mont blanc" or by holiday voucher ANCV.

Before the beginning of the course, you have to send us:

- **Your registration form** completed and signed with [parental authorization for minors \(minimum 12 years old\)](#).
- **A deposit of 260 €** to the school « Les Ailes du Mont Blanc » which confirms your registration. (it can be a cheque, cash, [bank transfer](#), [on line by credit card](#))
- **A medical certificate of aptitude** to practice paragliding (valid three years for 18-40 years old, one year for people older than 40 and competitors, and less than three months for minors).
- **Your FFVL membership (compulsory) with third party liability insurance included**, You can obtain this on line at this link www.ffvl.fr (code école 03940). To do it you must have your [medical certificate of « aptitude à la pratique du parapente »](#) from a french doctor. Exceptionally, nationals of the European Community and third countries may produce a certificate signed by a doctor registered with the council of his country, on condition that the applicant provide certification of registration of the doctor consulted. The school is required to verify the document. The member retains the medical certificate.

You can pay for your licence on line by credit card or by sending a chèque to FFVL date as postmark. If you arrive with this already done, we will gain some time for the course ! But if you do have difficulty in French we can help you or do it.

Cancellations:

In case of cancellation from us, due to adverse weather conditions, of half a day or a full day, you will pay only the half day you have done.

- Day course : approximately 6 hours long. 130 € /pers in group. 345 € /pers. in a private course.
 - Half-day course (mornings till 12:00) : approximately 4 hours long. 105 € /pers in group. 255€ /pers. in a private course.
- All morning courses started will be invoiced even if it is not possible to fly due to unsuitable conditions, if the team takes the decision to go to the flying site.
- Any booked day will be invoiced if you don't show up (except for exceptional medical reasons).
- The school reserves the right to modify or to cancel a course in case the minimum number of students is not met.
- If the client cancels his registration before the beginning of the course, we will issue a bill of cancellation costs.
- Less than 15 days before the start of the course: 100% of the deposit.

The trainee is responsible for his/her physical and psychological aptitudes to practice paragliding. You must be conscious that you are participating in "risk" sport. Remember you will be the only pilot onboard!

Flying is a voluntary act of breaking with everyday life. Your motivation and your implication will be the guarantee of your progression and safety.

Quality assurance:

- **To keep you informed**, our school is equipped with a cell-phone, an e-mail address and a website.
- **FFVL certification « French school of Free Flying » N° 03940** : this label is delivered by the French federation of free flying (FFVL). The school is declared as sporting establishment to the youth and sport ministry N° ET 001273 which guaranty the quality of the teaching.
- **The conformity of the flying sites** (adapted to a good pedagogic progression), quick access (road or ski lift)
- **The qualification of the instructors**, all with the state diploma (BEES 1st degree BPJEPS or DEJEPS or trainee-instructor DEJEPS). A Mountain-guide when on a glacier. All instructors and guides are covered by professional liability insurance.
- **The quality of the equipment** (Recent models, matched to the weight and level of the student)
- **Individual validation of your progression** using the FFVL paragliding passport (cycle 1 to 2, level white to brown, to the pilot licence).
